Information about The Public Sector Labour Relations Transition Act (PSLRTA)

SOUTH WEST CCAC EMPLOYEES

On March 6, 2007, the Ontario Labour Relations Board (OLRB) issued a decision on the appropriate bargaining units for the South West CCAC and set dates for voting for which union will represent you

Having regard to the agreement of the parties, the OLRB has set the bargaining units as follows:

“Unit #1

All office, clerical and technical employees employed by the employer, save and except Executive Assistants to the Senior Directors, Executive Assistants to the Executive Director, supervisors and persons above the rank of supervisor, persons employed in a confidential labour relations capacity pursuant to section 1 (3)(b) of the *Labour Relations Act*, and co-op students.

Unit #2

All registered nurses and allied health professionals employed as case managers and/or placement coordinators save and except supervisors and person above this classification, as well as those employed in a confidential capacity pursuant to section 1 (3)(b) of the *Labour Relations Act*.

For the purposes of clarity the position of Education Facilitator is included in case managers and/or placement coordinators.”

The OLRB has ordered the vote for South West CCAC to be held on March 27-28, 2007.

OPSEU has set up information meetings for professional and support staff for the weeks of March 12 and March 19. A schedule of the meetings is attached.

In the meantime:

OPSEU continues as your union. .Your collective agreement remains in place. OPSEU has a lot of experience with the PSLRTA process. We know that it can create a lot of uncertainty. We are here to support, assist and represent you. Please contact your steward if you have any questions.

We encourage you to come to the information meetings and get the information you need to make an informed decision. Representatives will be on hand to answer all your questions.
