### **Secret Tenders Issued by McGuinty Government to Private Companies for P3 Hospitals**

Toronto – The Ontario Health Coalition criticized the McGuinty government for issuing secret tenders for at least 7 hospitals across the province, including: Bluewater Health Sarnia; North Bay Regional Health Centre; Quinte Healthcare; Sault Area Hospitals; St. Joseph's Health Centre London; Sudbury Regional Hospital, and; Trillium Health Centre in Mississauga.

The Requests for Proposals (RFPs or tenders) issued for these hospitals have been provided to short-listed for-profit corporations bidding on the hospitals, but cannot be seen by Ontario residents who will pay for the hospitals. Although RFPs for most government contracts are available on MERX ([www.merx.com](http://www.merx.com)) - the website for public tenders - the P3 hospital tenders are secret.

The coalition accused the government of sacrificing the public interest in order to push through the P3 privatization of our hospitals over public opposition:

- the government has told the local hospitals not to reveal estimated costs at the outset of bidding meaning that they cannot be held accountable for cost overruns
- the government has issued secret RFPs for the first seven privatized P3 hospitals
- the government recently announced it will pay the companies to offset their costs for bidding on Ontario's P3s (from which the private companies stand to make extraordinary profits) making a mockery of repeated claims about transferring risk to the private sector.

“So far, the McGuinty government has put out to tender more than \$1 billion in secret privatized hospital deals,” noted Natalie Mehra, director of the Ontario Health Coalition (cost breakdown is provided in the attached backgrounder). “We asked the McGuinty government for copies of the tenders for their privatized hospital projects and were told that we cannot get them until the deals are signed. We asked the NDP opposition to get this information and they were also denied access.”

“Hospital officials are telling us that they have been told to keep the estimated cost of their new hospitals secret,” she continued. “The key information contained in the tenders includes the government's estimates of the costs and the scope of services to be privatized.”

Economist Hugh Mackenzie noted that the secrecy of the P3 hospital projects is not in keeping with normal government tendering. “I can go on the internet and look at all of Ontario's public tender documents -- except for the P3 hospitals. Why the secrecy? Is it possible that the government knows that the P3 bids are certain to come in above cost estimates? Is it possible that disclosure will open up a debate about the economics of P3 projects that the government is certain to lose? This secrecy is not in the public interest. It is in the political self-interest of a government that knows it cannot defend its P3 policy.”

“The government has repeatedly stated that it will protect public accountability and transparency in the privatized hospitals. This is now shown to be a farce. They know that by the time a freedom of information request goes through the contracts will likely be signed and impossible to change for twenty years or more,” concluded Mehra. “Keeping the tenders secret marks a new low point in public accountability surrounding McGuinty's privatized P3 hospital policy.”

### **33+ P3 Hospitals – More Than Any Other Province**

The government has now announced at least 33 P3 hospitals across Ontario. These announcements mean that the McGuinty government has pushed dramatically further down the road of P3 privatization than any other area in the country - including Ralph Klein's Alberta. A full list of announced P3 projects is below.

### **What is secret**

The government will not allow the legislature or citizens to see the RFPs - or tenders - for the P3 hospitals. This is unusual – RFPs for most government contracts are available on MERX ([www.merx.com](http://www.merx.com)) - the website for public tenders. The key information contained in the tenders includes an estimate of the cost of the hospitals and the scope of services to be privatized.

We believe the government has an interest in reducing its public accountability by hiding this information for several reasons:

- 1) costs will likely to increase dramatically as the government and hospitals negotiate the deals with the multinational private consortia. The Ottawa P3 increased from \$100 million at the outset of negotiations to \$132 million when the deal was signed. The Brampton P3 increased from \$350 million to \$550 million.
- 2) the government has pretended all along that it is not privatizing when it is. It has renamed the P3s as AFPs (alternate finance and procurement). Showing the RFPs (tenders) will provide documentary evidence of which services and non-profit assets are being handed over to private for-profit companies.
- 3) the public will be able to see how the privatization deepens and costs increase through the negotiations if we are able to compare the final deals with the RFPs.

"I want to make it very clear that the McGuinty government is on the side of Ontario families and individuals who want the best health care. Ontario is not giving up control of its hospitals to private interests," said David Caplan, Minister of Public Infrastructure Renewal. "All Ontario hospitals will remain publicly owned, publicly controlled and publicly accountable." *MPIR Press Release "Provincial Government Committed to Public Ownership and Control of Province's Hospitals to Protect Public Interests".*

When announcing its infrastructure program, entitled *Building a Better Tomorrow: An Infrastructure Planning, Financing and Procurement Framework for Ontario's Public Sector*, the Minister of Public Infrastructure Renewal, David Caplan outlined five fundamental principles governing the approval of infrastructure projects and the selection of financing options:

- The public interest is paramount
- Value for money must be demonstrated
- Appropriate public control/ownership must be preserved
- Accountability must be maintained
- All processes must be fair, transparent and efficient.

### **More than \$1 Billion in Privatized Hospital Infrastructure Tendered in Secret RFPs**

The estimated costs of the P3 hospitals that have been tendered so far. Estimates are as revealed by local hospitals prior to the news blackout:
